

## Privacy Policy

Please note that this version is not a binding translation. Only the German version is legally binding.

We process your data on the basis of legal regulations EU and Telekommunikationsgesetz 2021 (TKG 2021)-Austria. We inform you about the most important aspects of data processing within this website.

### Data storage - Data transmission:

Every time you visit the website, we store your current IP address and your explicit consent to the use of cookies. We also save your anonymous product selection. The storage of this data is required in order to prepare a product purchase, to assign you the selected articles, for the order process and for the contract execution. For the ordering process and contract management, you must create an account and give us your name, email address, billing address, delivery address, a password of your choice and, if applicable, your telephone number and UID number.

As part of the payment process, we transmit this data and the data you provided when paying to the processing bank or payment service provider to debit the purchase price. If you pay by credit card, we only know the last four digits of your credit card, card issuer and cardholder. All bank and account data are transferred directly to the payment service provider's systems and are not stored by us. The password you have chosen will be stored by us, encrypted according to an industry standard, and unknown to us.

We will transfer your name and delivery address to the transport company / shipping company commissioned by us for the delivery of the goods. We also transmit your data to our tax consultants and, if necessary, to our legal representatives and to those who are required to handle the contract.

In the case of a contract, all data from the contractual relationship are stored until the expiry of the tax retention period (7 years). In addition, data such as name, address, purchased goods and date of purchase are stored until the end of product liability (10 years).

You can delete your customer account at any time through the website without having to contact us.

### Cookies:

Our website generates and stores first-party cookies. The cookies we set are each created for a certain period of time. You can also delete these cookies. The cookies allow us to recognize your browser on the next visit and are required for the functionality of the website. We also use cookies to store and process the items in your shopping cart and to recognize your user preferences and save them for future visits.

If you deactivate the cookies we set, which are absolutely necessary for the functioning of the website, these will be restored as the website continues to be used. You may refuse the use of cookies by selecting the appropriate settings on your browser, however please note that if you do this you may not be able to use the full functionality of this website.
